We are excited to begin accepting applications for the 21st Annual Thunder in the Valley Air Show, the largest family friendly outdoor event in the Chattahoochee Valley. The air show will take place April 7 & 8, 2018 at the Columbus Metropolitan Airport.

We are now taking reservations for **non-profit** exhibitors. Spaces will be on the flight line and gate entrances. Minimum space begins at 10 ft. x 10 ft. The cost per space is \$5 per square foot. No electricity will be available and all exhibitors are responsible for all necessary equipment for their set-up/display including, tarps, tents, chairs, tables, generator, as needed.

We will issue two exhibitor passes and one parking permit to each exhibitor. All other requests must be preapproved. We can also refer you to a source for any equipment or set up materials you may need.

- Applications are accepted first come, first served basis and must be accompanied by check or money order
- Any giveaway items must be approved by Thunder in the Valley Air Show. Please contact the [Exhibitor Coordinator](#)
- All license and operator permits are your responsibility
- You may not sell items or solicit donations. Exhibits are for public information only
- You may not share space with any other organization
- All booth set up items are the booth operator's responsibility (e.g. tents, tables, chairs, etc.)
- No open flame, heat source or airborne dispersals permitted within 100ft of aircraft
- No political displays
- No housing or overnight camping will be allowed on airport grounds
- No electricity is available. You must provide your own generator, if needed
- Storing items in tenant hangars is prohibited
- Airport security provided during closed hours
- Booth/display clean up is your responsibility. Please be sure you have a trash receptacle, with a liner, in your booth. Please bag any booth-generated wastes and dispose of properly in dumpsters on the airport property.
- Charitable organizations which were recipients of the 2017 air show proceeds are provided space to promote community awareness for their organization. Sale of items or requests for donation is unauthorized
